### Minutes

Art Trottier motioned to approve the October 9, 2024 minutes as presented. Nick Silver seconds it. (motion **PASSED**)

### Commissioner's & Ice Convenor Report

Dave Bigelow asked the presidents how the games in Mammoth are doing. They answered good.

Dave informed the president that he forwarded the list of the top teams in each AA (14UAA & 16UAA) divisions. Dave stated that by the end of this week he should be able to draw the line and determine the top 12 teams in each age division. In the 14UAA division, the number of teams are unbalanced, meaning there are 8-Teams in one pool and 7-Teams in the other pool. The question remains where do we draw the line? If we advance 12 teams, then there are 3-Teams remaining having to play the relegated schedule.

We will wait until after this weekend and Dave will send an email to the presidents to vote on the number of teams advancing in the 14UAA division.

AA Scheduling for the National Bound teams will need to be finalized quickly as well as the relegated teams' schedule. Cannot give back the December ice slots to the clubs until AA is finalized followed by the Mites and then the 18UAA division schedules.

Rosemary reminded the presidents that the deadline to submit bids for hosting the SCAHA Playoffs is December 22, 2024. Rosemary recapped the new process for the CAHA Select Camp. And finally, Rosemary Voulelikas highlighted some of the challenges this year with the referees and the incident reports; specifically, officials under or over reporting penalties.
